ERIE COUNTY AUDITOR

A RESOLUTION REQUESTING THE ERIE COUNTY AUDITOR TO ASSESS LOTS AND LANDS OF MARGARETTA TOWNSHIP FOR THE LIGHTING OF STREETS, ALLEYS, PUBLIC WAYS AND OTHER PUBLIC PLACES.

WHEREAS, the Margaretta Township Trustees have determined that it is necessary to adopt special assessments for the lighting of street, alleys, public ways and other public places with the Margaretta Township limits and

NOW, THEREFORE, BE IT RESOLVED BY THE TRUSTEES OF MARGARETTA TOWNSHIP, ERIE COUNTY, STATE OF OHIO:

SECTION 1. The Trustees have determined that the cost and expense of the lighting of streets, alleys, public ways and other public places in Margaretta Township and the furnishing of electrical energy therefore for the tax years 2020-2022 be paid for by special assessment upon all of the lots and lands as listed on the real estate duplicate, excluding parcels that are in an exempt classification, with Margaretta Township, and that for such purpose there shall be levied and assess according to the percentage of tax valuation of said lots and lands for a total amount of \$18,000, for each of the aforementioned tax years, payable in two equal installments in each of the tax years as set forth herein. Furthermore, the Trustees hereby authorize and direct the Erie County Auditor to place this assessment upon the tax duplicate and collect as other taxes in tax years 2020-2022.

SECTION 2. That it is found and determined that all formal actions of the Trustees concerning and related to the passage of this Resolution were passed in an open meeting to the Margaretta Township Trustees, and that all deliberations of the Trustees and any of their committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including *Section 121.22 of the Ohio Revised Code.*

Section 3. That the Trustees have determined that the cost and expense of the lighting of the streets, alleys, public ways, and other places within Margaretta Township and the furnishing of electrical energy therefore for the tax years of 2020-2022 to be paid by special assessment is directly related to the immediate preservation of the public safety and general welfare of the Township of Margaretta, Erie County, State of Ohio. Therefore, this Resolution is hereby declared to be an emergency measure and as such, this Resolution shall take effect

immediately upon its adoption and due authentication by the Margareta Township Trustees and Fiscal Officer respectively.
